## NOTIFICATION

In exercise of the powers conferred by the provise to Article 309 of the constitution of India, and in supersession of the existing Recruitment Rules for the Post of Constable (Men & Women), 2019, the Governor is hereby pleased to make the following Rules regulating the method of common Recruitment Rules to the Post of Constable of Tripura Police, namely:-

#### Short title and commencement -

- These rules may be called Recruitment Rules of Constable of Tripura Police (Men & Women) Rules, 2021.
- (ii) They shall come into force from the date of their publication in the official Gazette.

## 2. Name of the post -

The name of the post shall be as specified in Column No.1 of the Schedule at Annexed bereto.

Number of posts, classification & Scale of Pay -

The number of the said post, its classification and Scale of pay attached thereto shall be as specified in Column No.2 to 4 of the Schedule Annexed hereto.

## Method of Recruitment, age limit and qualifications etc.-

The method of recruitment to the said post, age limit, educational and other qualifications matters relating to the said post shall be as specified in Column No.5 to 13 of the schedule.

Disqualification: - No person-

 (a) Who has entered into or contracted a marriage with a person having a spouse living, or

who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts.

Provided that the State Government may, if satisfied that such marriage is permissible under the personnel law applicable to such person and the other party to the marriage that there are other ground for so doing, exempt any person from the operation of this Rule.

#### 6. Power to relax -

Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in the writing and in consultation with the TPSC, relax any of the provisions of these Rules with respect to any class or category of persons.

#### 7. Repeal-

The existing Recruitment Rules to the post of Constable (Men & Women) hereby stand repealed with immediate effect and are replaced by this Recruitment Rules according to the Schedule enclosed because.



During period of probation, the recruited Constable will undergo basic training and other training as may be prescribed by the DGP, Tripura, failure in which will entail discharge from service by the appointing authorities without proceedings.

# PROCEDURE FOR SELECTION OF CANDIDATES FOR DIRECT RECRUITMENT AS CONSTABLE OF TRIPURA POLICE:-

Candidates will be measured for height and/or chest expansion at the time of physical endurance test.

Those candidates who possess the required physical qualifications will have to undergo
a physical endurance test, which is qualifying in nature. The details are mentioned below:-

#### FOR MEN

SL. No.	Event	Time/Target (Minimum)
1.	4 Km run	21 minutes
2.	Long Jump	14 feet
3.	Shot put (7.26 KG)	18 feet
4.	High Jump	4 feet
5.	Pull ups	5 pull ups at one go, maximum 2 attempts.

#### FOR WOMEN

SL. No.	Event	Time/Target (Minimum)
1.	1.6 Km run	9½ Minutes
2.	Long jump	10½ feet
3.	Shot put (4 KG)	14½ feet
4.	High jump	3.4 feet
5.	Hanging by Bar	30 seconds

Women candidate shall be required to submit self declaration certifying that she is not pregnant on the date of the physical endurance test.

- Those who qualify in endurance test will be put through a written examination, objective type,
  maximum marks- 85%, to test their general awareness and IQ. Examination will consists of one
  paper of one hour duration to be answered in Bengali, Hindi, English or Kokborok as per choice of
  the candidate.
- Those who qualify in written test will have to undergo a personal interaction with the Recruitment Board. The maximum marks for the personal interaction will be 15%.

Full marks - 100 (Written examination and Personal Interaction)

- a. Written marks S5
- b. Personal interaction marks 15
- The appointment will be from the merit list to be determined on the basis of aggregate score in written examination and personal interaction.
- The appointed candidates shall have to undergo basic training for one year or as prescribed by the DGP Tripura. The candidate will be eligible to get his annual increment only after successful completion of their basic training.
